Pilgrimage Liability Waiver

Please read this document carefully before signing. This Pilgrimage Liability Waiver ("Waiver") is a legal agreement between you, the participant ("Participant"), and the Center for Peace West, a non-profit organization ("CFPW"), concerning the participation of Participant in an international pilgrimage organized by CFPW. By signing this Waiver, Participant acknowledges and agrees to the terms outlined below:

1. **Assumption of Risks:** Participant understands that participating in an international pilgrimage involves certain risks and dangers, including but not limited to accidents, illness, injury, theft, and unforeseen events in unfamiliar locations. Participant agrees to assume all risks associated with the pilgrimage and any related activities.
2. **Health and Insurance:** Participant attests that he/she is physically and mentally fit to participate in the pilgrimage. It is the responsibility of Participant to obtain adequate travel and health insurance coverage for the duration of the pilgrimage, including medical and emergency evacuation coverage.
3. **Release of Liability:** Participant releases and discharges CFPW, its directors, officers, employees, volunteers, and agents from any and all liability, claims, demands, actions, or causes of action arising out of or related to any loss, damage, or injury, including death, that may be sustained by Participant during the pilgrimage.
4. **Compliance with Laws and Regulations:** Participant agrees to comply with all laws, regulations, customs, and orders of the countries visited during the pilgrimage. Participant is responsible for obtaining any required travel documents, visas, and vaccinations.
5. **Personal Belongings:** Participant is solely responsible for safeguarding and securing his/her personal belongings during the pilgrimage. CFPW shall not be liable for any loss or damage to Participant's personal belongings.
6. **Itinerary Changes:** CFPW reserves the right to modify the itinerary or cancel the pilgrimage due to circumstances beyond its control, including but not limited to natural disasters, civil unrest, or government advisories. In such cases, CFPW will make reasonable efforts to offer suitable alternatives or refunds.
7. **Media Release:** Participant grants CFPW the right to use photographs, video, or audio recordings of Participant taken during the pilgrimage for promotional purposes without compensation.
8. **Medical Treatment:** In the event of a medical emergency, Participant authorizes CFPW and its representatives to secure medical treatment, including hospitalization and/or evacuation if necessary. Participant agrees to assume all costs associated with such medical treatment.

9. Binding Effect: This Waiver shall be binding upon Participant, his/her heirs, executors, administrators, and assigns.

10. Governing Law and Jurisdiction: This Waiver shall be governed by and construed in accordance with the laws of The State of Oregon. Any disputes arising under or in connection with this Waiver shall be subject to the exclusive jurisdiction of the courts of The State of Oregon.
